

Year-on-year inflation rates in 2018





Breakdown of the top 10 contributors to inflation, Oct 2018



Key urgent reform: rice tariffication

Key provisions

- NFA mandate limited to emergency buffer stocking.
- Convert quantitative restriction and minimum access
 volume into tariffs to allow freer importation of rice.
- Remove import licensing.
- \circ Use tariff revenue to improve productivity of agriculture.

Potential impact

- \odot Inflation in 2019 can be 0.6 to 0.7 ppt lower.
- \odot Rice price can fall between 2 to 7 pesos per kilo.

Main causes of inflation

- Rice and agri supply
- Oil imports
- Tax reform
- More money to the people
- Better tobacco compliance


Reducing food prices

Administrative Order No. 13 s. 2018 Removing non-tariff barriers and streamlining administrative procedures on the importation of agricultural products

- Removal of non-tariff barriers and streamlining of administrative procedures
- Additional rice importation
- Importation of fishery products
- Expedite unloading of agricultural imports
- Other remedial measures to improve logistics, transport, distribution, and storage of agricultural products
- Creation of a surveillance team

Food items have overtaken non-food items as the main driver of inflation in 2018.

Solutions to inflation

- The Department of Agriculture (DA) is key in bringing down food prices.
- Administrative Order 13 and Memorandum Circulars 26, 27, and 28 give DA the power to increase food supply and bring down food prices.
- Quick enactment of the Rice Tariffication Law is needed.
- DSWD and DOTR need to fast-track distribution of cash transfers and fuel cash cards.

Solutions to inflation

• Increase agricultural productivity by:

 Individualizing the agrarian reform collective titles to improve property rights and incentivize farm production.

 Improving efficiency by reallocating the budget from favoring certain crops (e.g., rice) and production inputs into more broad-based farm infrastructure, R&D, and support service.




Draft statement of support for National Union of Career Executive Service Officers As of 05 November 2018

The National Union of Career Executive Service Officers (NUCESO) supports the Administration's initiative to spearhead the passage of Package 2 of the Comprehensive Tax Reform Program in Congress. As lifelong government workers, we believe that Package 2 is aligned to this Administration's main economic agenda, especially as it relates to improving competition between firms and empowering the owners and employees of small and medium enterprises (SMEs).

- Package 2 makes our tax rate more comparable vis-à-vis our neighbors. Package 2, as currently conceptualized, aims to reduce our corporate income tax rate to 20 percent by 2029. This makes our tax rate more comparable with countries in the ASEAN. We expect that such reduction makes our country more attractive to foreign investors, who would otherwise be turned off by our country's extremely high tax rate.
- 2. Package 2 rationalizes fiscal incentives. Incentives such as tax holidays are doled out with the intention of helping firms begin operations in sectors that have not yet fully-matured. Unfortunately, the current system is both inefficient and prone to abuse, resulting in multiple redundancies that could have otherwise went to other government programs. Package 2 seeks to overhaul the incentives system by requiring that they be awarded with the following criteria in mind: performance-based, time-bound, transparent, and targeted.
- Package 2 makes the tax system more efficient. As a direct result of having the incentives system simplified, the complexity of the tax code will be reduced. Additionally, the government has promised to spearhead further measures to simplify administration and increase compliance.

The lifetime of service that most of our members have given for the Filipino people convince us that the Administration's tax reform initiatives are necessary leaps to the right direction. We therefore stand committed in enthusiastically supporting the Administration in its efforts to lobby Commers to nase Parkane 2


