





























SULONG PILIPINAS: Local Governance Discussions

September 20-21 (for ARMM, Visayas and Mindanao), SMX Davao October 3-4 (for Luzon and NCR), Dusit Thani, Makati

CONCEPT NOTE

The month of October, 2016 marks the 25th anniversary of the Local Government Code of 1991. This milestone is befitting of a celebration that will highlight the gains of the LG Code towards realizing a genuine and meaningful local autonomy, and enabling local governments to attain their fullest development as self-reliant communities and make them more effective partners in the attainment of national goals. The theme of the celebration is anchored on three (3) dimensions of the 25 years of journey of local governance in the Philippines: Pagsulong. Progreso. Pagbabago.

Aligned with the sectoral agenda-setting discussions of the Office of the President – Cabinet Secretary, the Department of Interior and Local Government (DILG), with the Union of Local Authorities of the Philippines (ULAP) and its member leagues, are organizing the Sulong Pilipinas: Local Governance Discussions, which is one of the series of activities of the 2016 Local Government Congress. This aims to strengthen the ties between the local peace and order, as planned by the Local Government Units (LGUs) and the Philippine National Police, and forward nationwide participation in making our country peaceful and safe, while concurrently planning strategies for local social delivery and social development.

Moreover, the consultations is seen as avenue for DILG to discuss with the local officials their new program, MASA MASID (Mamamayang Ayaw sa Anomalya - Mamamayang Ayaw sa Iligal na Droga). MASA MASID is a barangay-based program developed by DILG to address the country's current problem in criminality, illegal drugs, and corruption. It encourages the collaboration of different sectors in the community, which will be mobilized to complement the efforts of the National Government in its advocacy to eradicate illegal drugs and illegal drug activities.

The consultation workshop shall serve as a venue for all the key leaders to collaboratively craft action plans to effectively eradicate crime and drug as a prerequisite in promoting social delivery and social development at the local level.


Approaching the question on how these forces will work together in realizing the overall agenda, the diagram below illustrates the strategic interface of national and local governments in combining anticriminality and anti-drug campaigns with the responsibility of the local governments to deliver social progress and development.

The aim is to gather the priorities and capacities of the local governments on security and social development dimensions, focusing on local peace and order and local human development index (income and employment, livelihood, education and health).



The output of the discussions is a listing of priorities, plans, and target outcomes of local governments per province, and per region. The outputs will be processed and collated by ULAP and DILG, for submission and discussion with the Office of the Cabinet Secretary and National Government Agencies, for alignment for the national six-year agenda. The discussions will be guided by the following framework:

On administrative and logistical concerns:

• DILG is issuing a Memorandum Circular that allows local funds to be used for transportation, accommodation, and per diem of the participants. The MC will be sent by DILG units, and ULAP and its member leagues the soonest it is released. This means that the LG representatives would have to book their own flights and accommodation arrangements. The LG Leagues will be extending coordination and administrative support on these matters.

WORKSHEET FOR LOCAL GOVERNMENTS' PRE-WORK

The worksheet is distributed to the local governments for their required pre-work. The worksheet is informed by the thematic local peace and order, and local human development index indicators, and the mechanisms through which these themes are reflected in local governments. The performance and outcomes indicators are based on existing measures, such as the Seal of Good Local Governance (SGLG) and the Local Governance Performance Management System (LGPMS), among other agency measurement systems. During the Sulong Pilipinas discussions, the consolidated priorities and capacities of the local governments, as well as the opportunities for national government support, will be identified and documented.

	 Municipal-level: It is recommended that the Municipal Mayor come up with a worksheet that reflects the development plans and investment plans. Also as representatives of the LMP in the provinces, the attending top officers should bear in mind that the plans that they will bring will be considered representative of the priorities and capacities of the municipalities in the provinces. Barangay level: It is recommended that the Barangay Chairpersons come up with a worksheet that reflects the development plans and investment plans. Also as representatives of the LNB in the provinces, the attending top officers should bear in mind that the plans that they will bring will be considered representative of the priorities and capacities of the municipalities in the provinces.
	This means that there does not have to be a unified provincial plan that encompasses all levels before the summit. The purpose of the Workshop 1 is alignment of the plans that that the LGs are bringing. The assumption is that every plan is representative of the priorities and the capacities of the LGs in every province, and are reflective of the processes required for coming up of such plans (LG units and public consultations).
Do we have to fill out every detail?	Ideally yes, but the processing of the worksheets that comes during and after the Sulong Pilipinas discussions take into account the differences in the responsibilities and capacities of each LG level. For instance, there is recognition that on health, provinces are focused on the tertiary hospitals and have greater emphasis on the Service Delivery Networks, while municipal and barangay levels are focused on primary health care and community outreach.
	However, with due consideration with the limitations of LG capacities, it is best to reflect in the worksheets if the LG have limited capacity or resources for certain outcome areas. IF THE LOCAL GOVERNMENT DOES NOT HAVE IDENTIFIED BASELINES FOR 2016, PLEASE PUT N/A.
	This gives national agencies, DILG in particular, ULAP and the LG leagues a realistic sense of where national and local governments must interface with the desire of increasing outcome attainment in security and social development targets.
	Hence it is encouraged that the LGs consider answering the worksheet with great care. The worksheets are also designed to reflect indicators
